By signing said consent, the patronage agreed to include the total amount of any patronage allocation or dividend (not just the cash portion thereof) in his/her gross taxable income in the year during qualified written notice of allocation is received. While you are required to sign the foregoing consent, it relates to you only to the extent that your purchases from the association, or sales to the association, are related to you taxable income.
